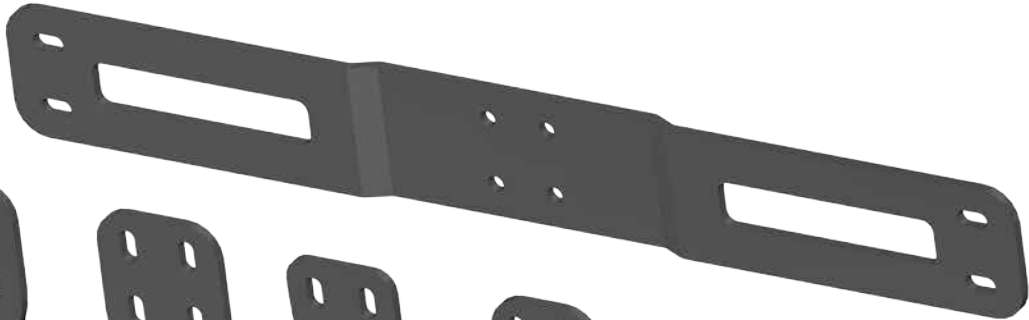

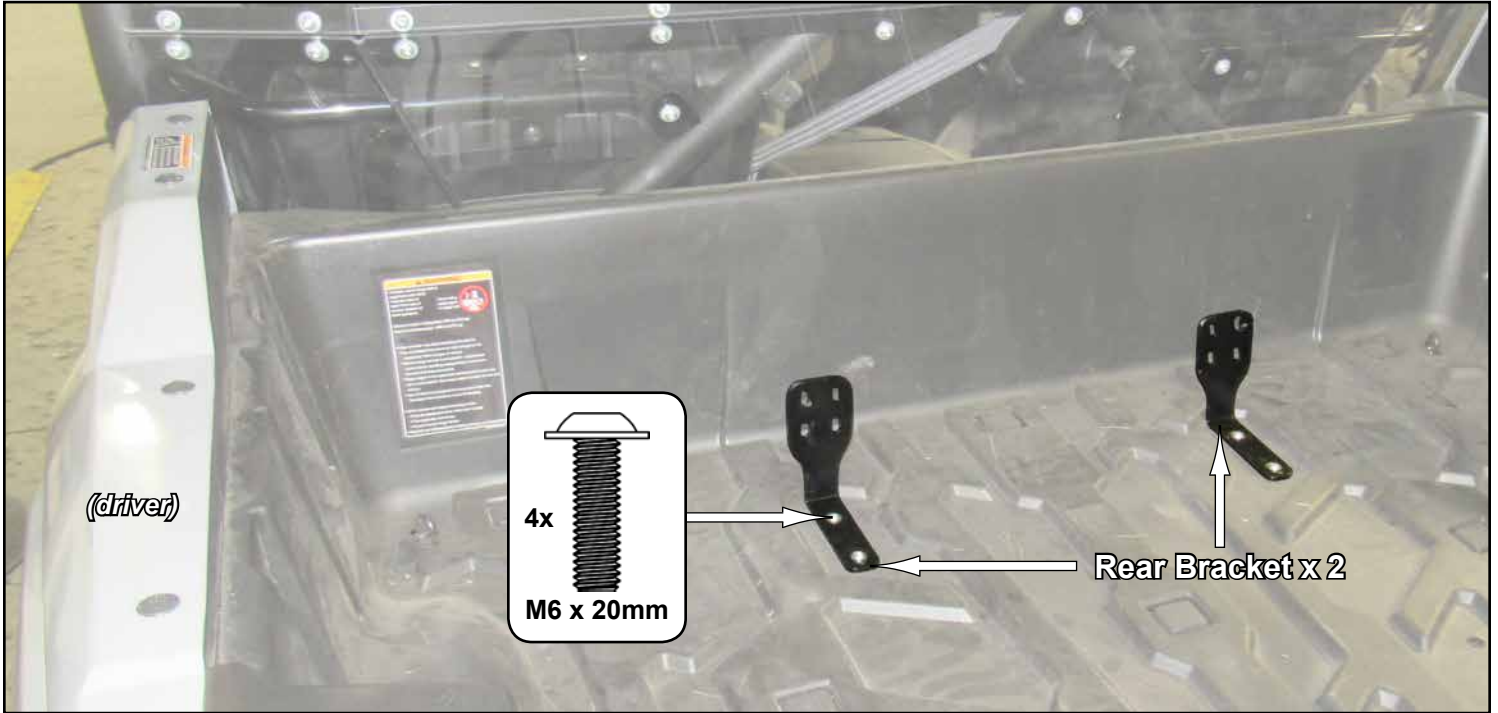

## Center Mounting

- Install Rear Brackets with hardware shown; do not tighten hardware completely.



- Temporarily secure Cargo Box to Rear Brackets with hardware shown; do not tighten hardware completely.



- Align Cargo Box in Bed. Carefully remove Cargo Box and tighten Rear Brackets hardware completely.

- Install Bracket A with hardware shown; do not tighten completely.



- Temporarily secure Cargo Box to Bracket A with hardware shown; do not tighten hardware completely.



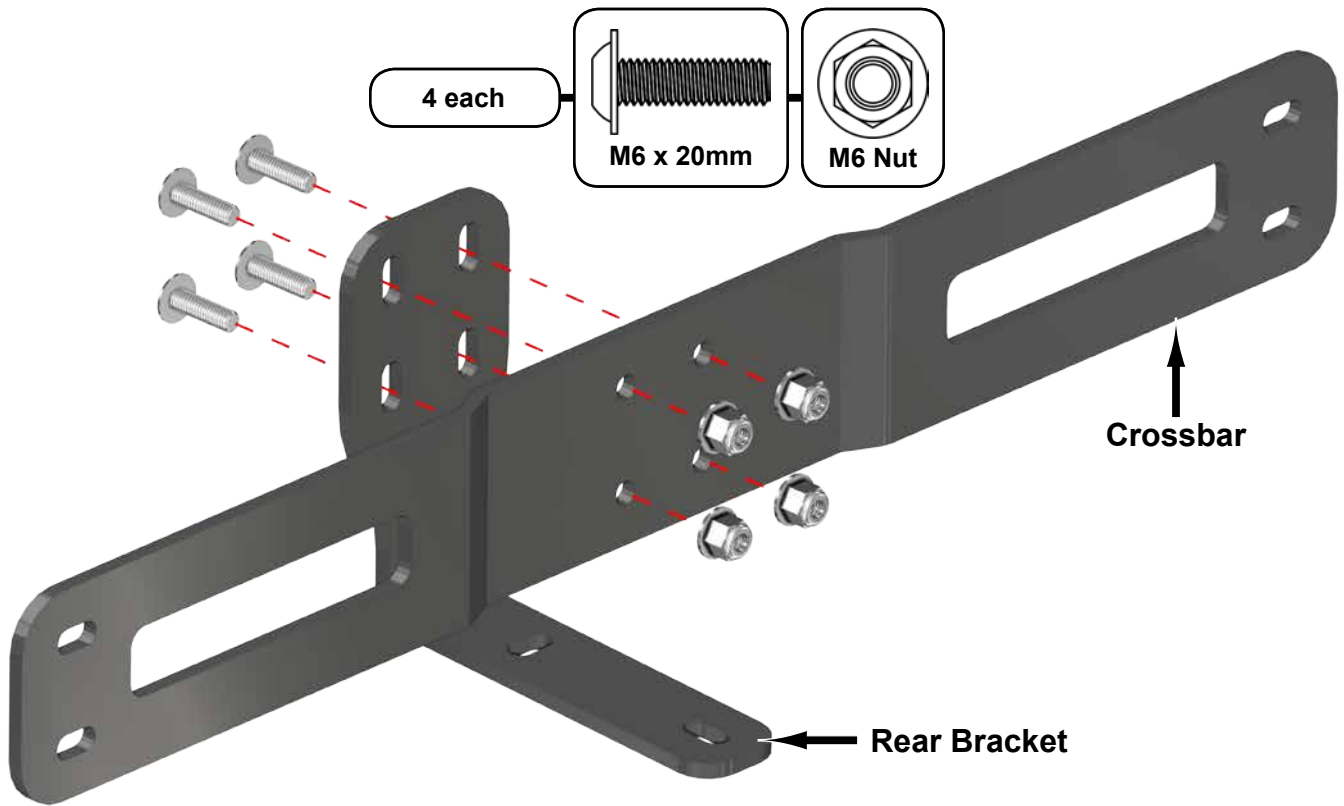
- Align Bracket A to Cargo Box. Carefully remove Cargo Box and tighten Bracket A hardware completely.

- Secure Cargo Box with hardware shown; tighten completely.

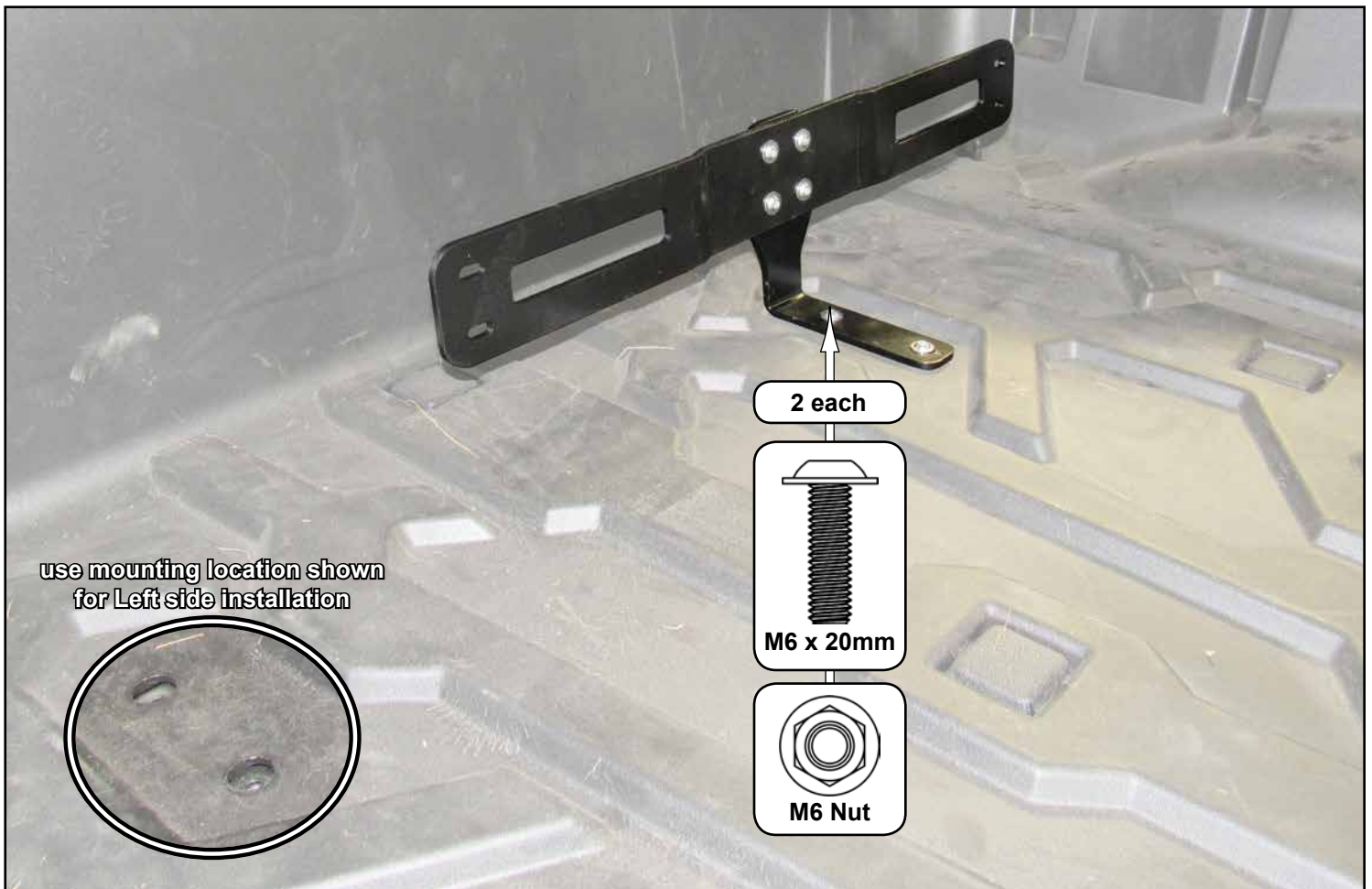


### Side Mounting (right side shown)

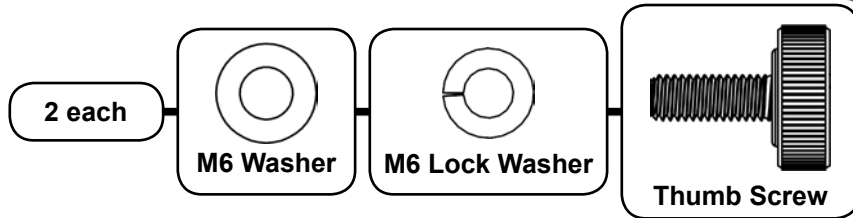
- Install Crossbar to Rear Bracket with hardware shown; do not tighten completely.



- Secure Crossbar to Bed with hardware shown; do not tighten completely.

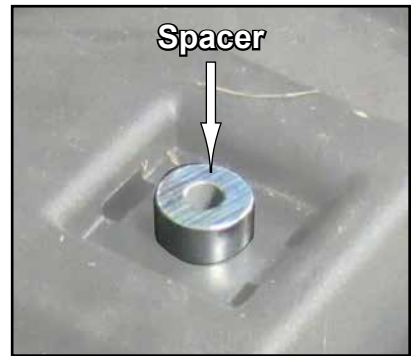
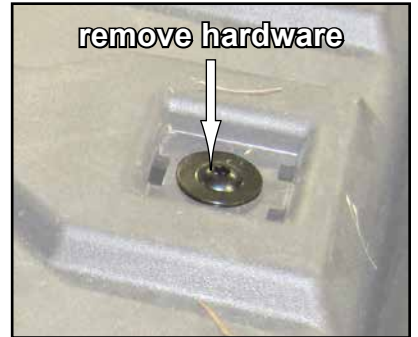


- Temporarily secure Cargo Box to Crossbar with hardware shown; do not tighten hardware completely.

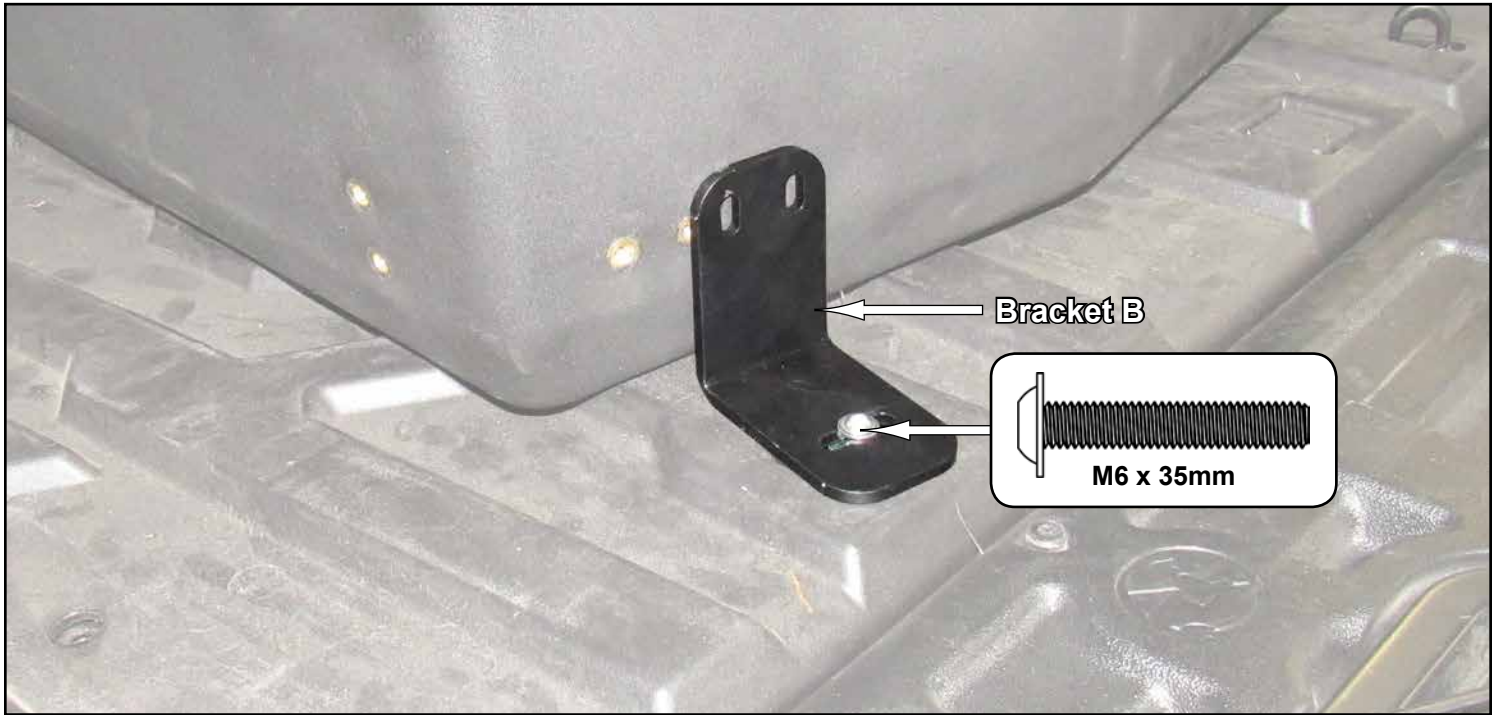


- Align Cargo Box to Bed. Carefully remove Cargo Box and tighten all Crossbar hardware completely.

- Install Spacer to location shown.



- Install Bracket B with hardware shown; do not tighten completely.



- Align holes in Cargo Box and Bracket B; tighten hardware completely.

- Secure Cargo Box with hardware shown; tighten completely.
