

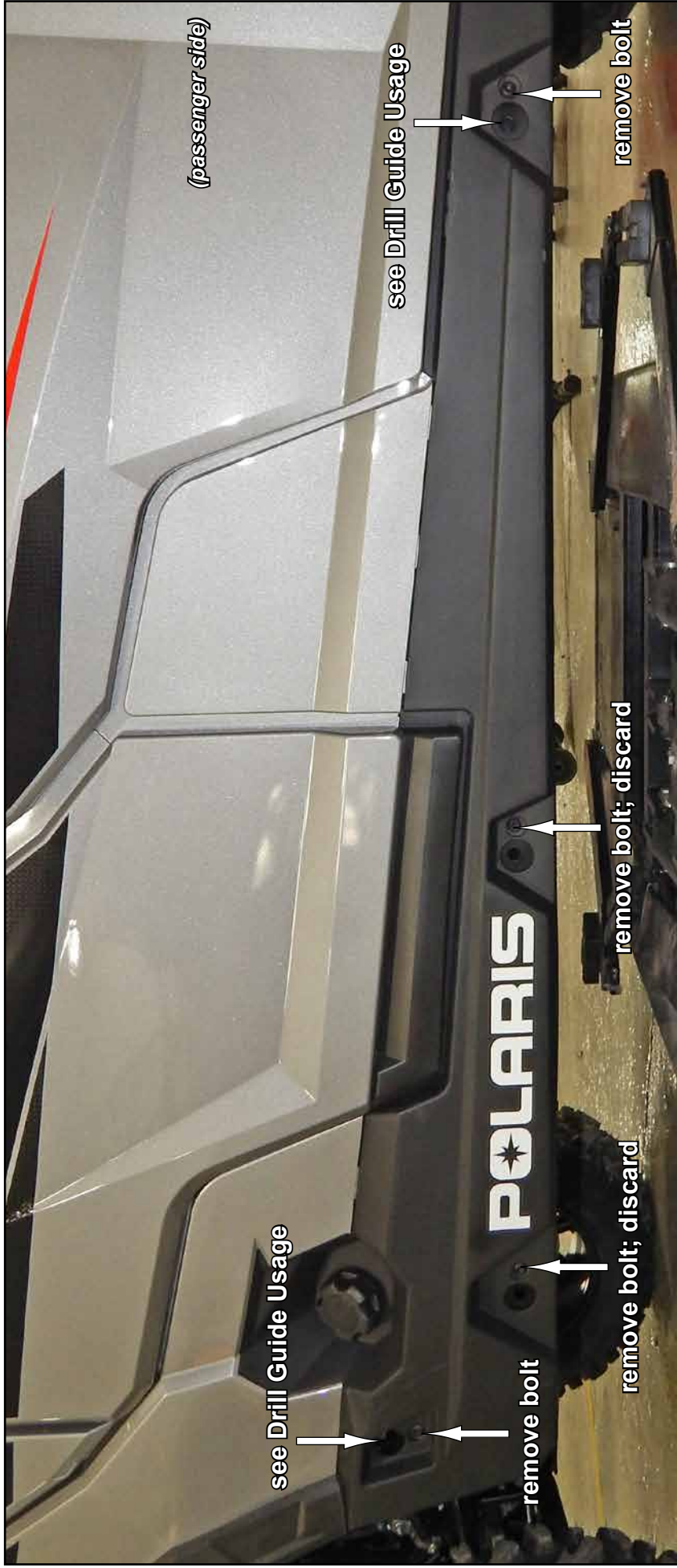

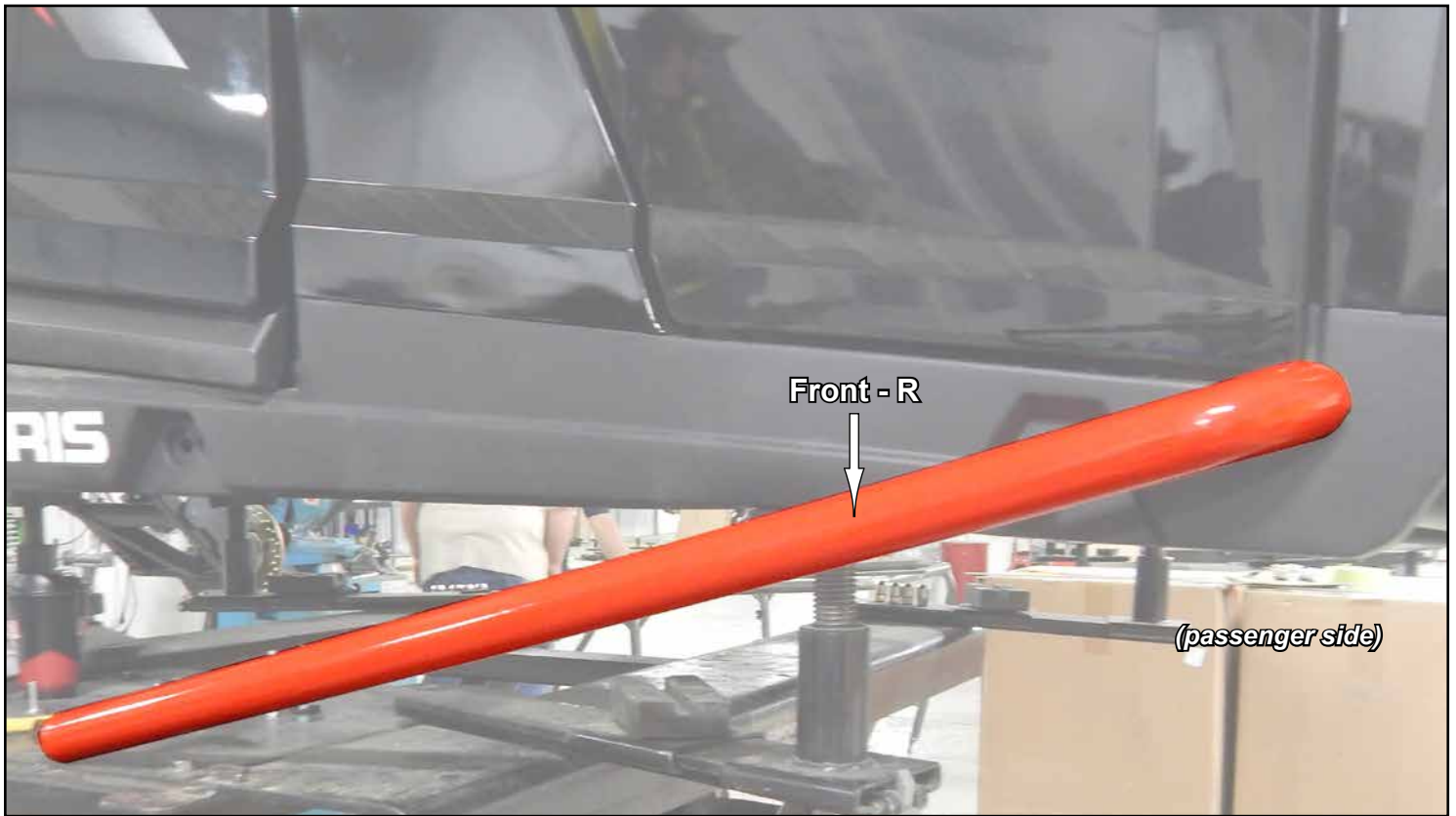

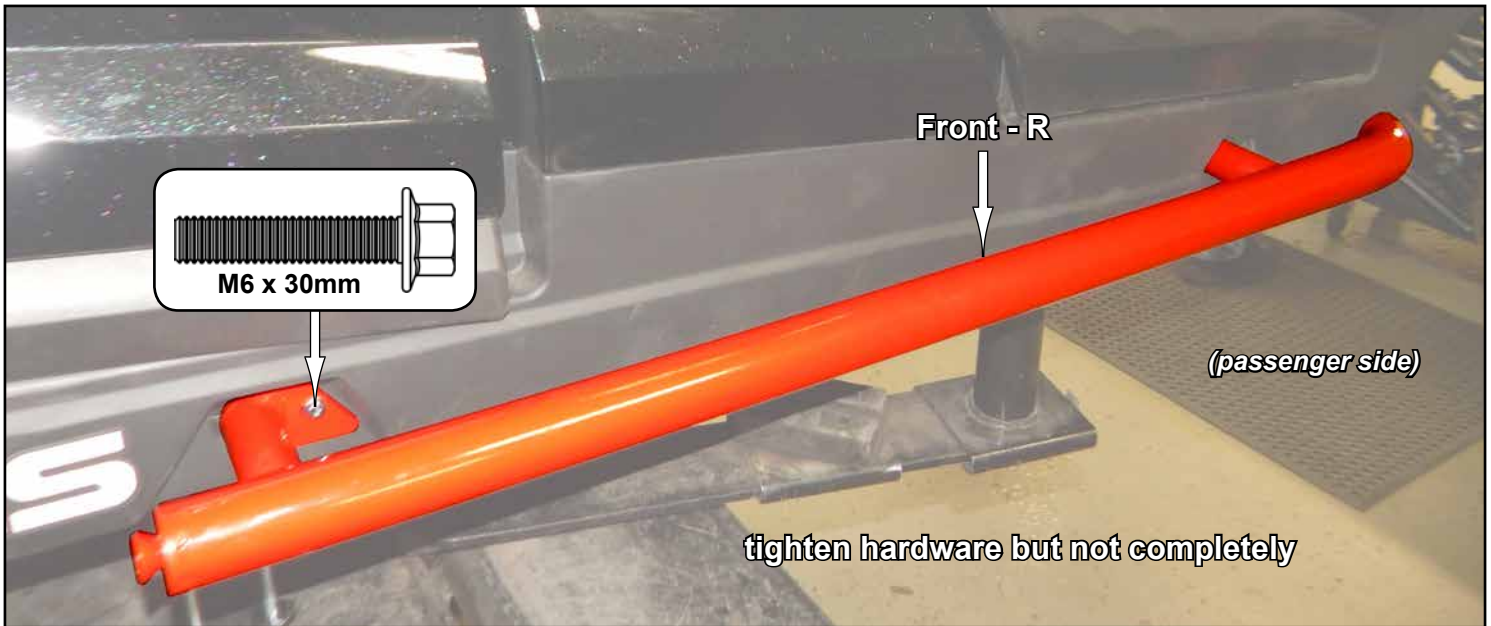

- Install and secure Front - R with hardware shown.



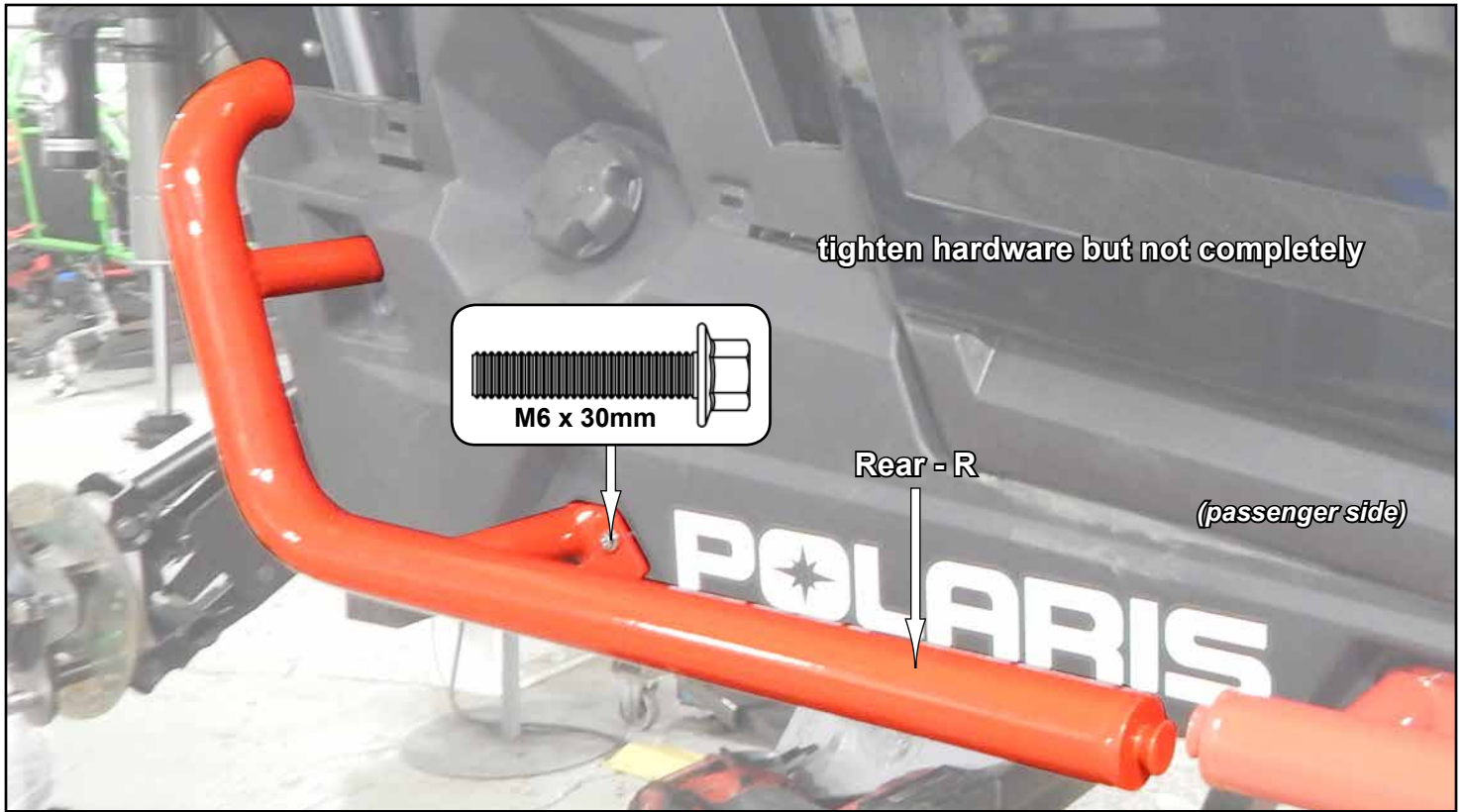
- Secure Front - R with hardware shown.



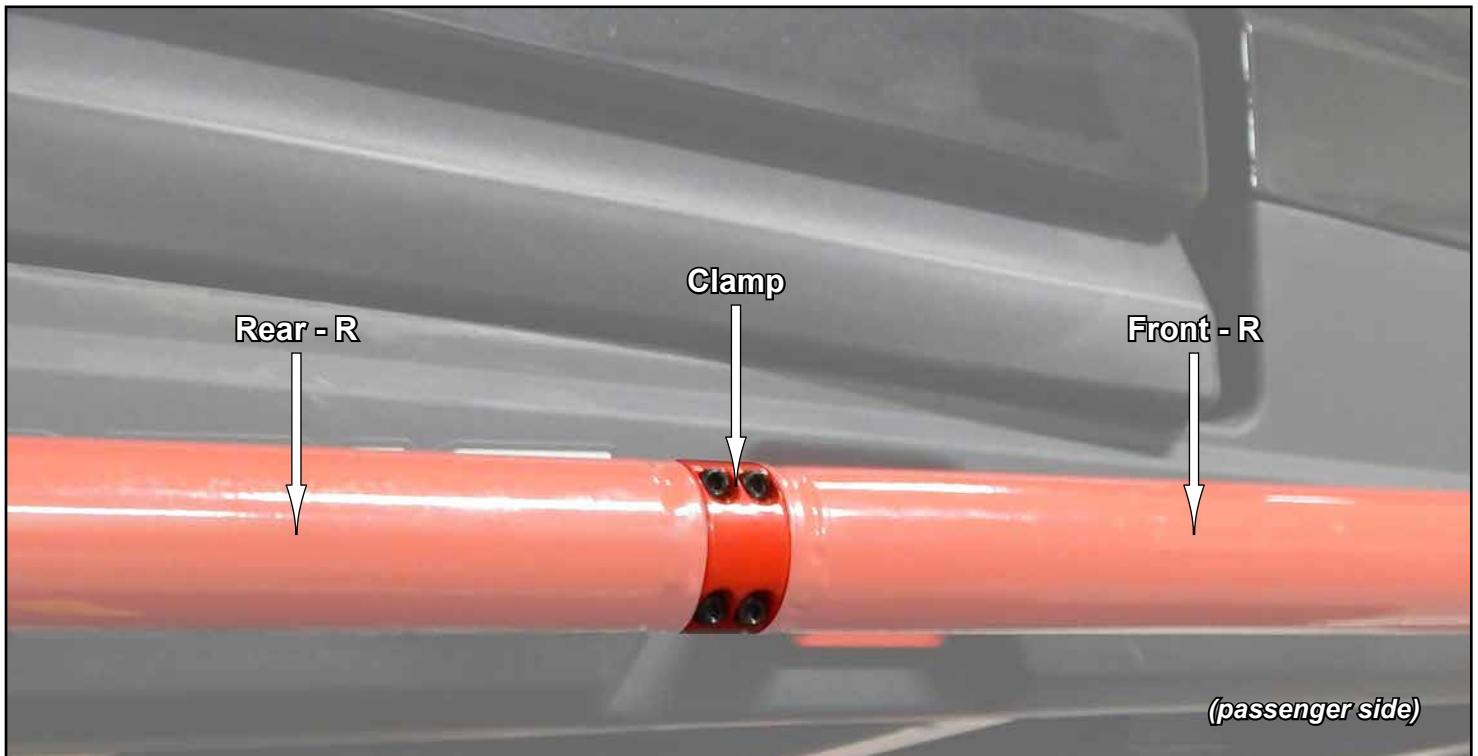
- Install hardware shown to upper rear mounting location.
